Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements), Regulations 2015 ("SEBI Listing Regulations") read with Para B of Part A of Schedule III of SEBI Listing Regulations, we hereby inform that IAC International Automotive India Private Limited (formerly known as Lumax Integrated Ventures Private Limited) (hereinafter referred to as "IAC India"), a material Unlisted Wholly-owned Subsidiary of the Company has today, i.e., May 28, 2025 inaugurated its two (2) new manufacturing plants at Chakan (Pune), Maharashtra.

IAC India is a well-established Tier-1 plastic interior systems and components supplier to key automotive OEMs in India including Mahindra, Maruti Suzuki, Volkswagen and Volvo Eicher Commercial Vehicles among others. IAC India is a leader in the vehicle interior space and the sole supplier of integrated cockpits and door panels for the recently launched BEV model from Mahindra – BE6 & XEV9e. It also has a strong and well-established engineering centre providing advanced design and engineering services to customers in India and overseas which provides it a competitive advantage.

This strategic expansion marks a significant milestone in IAC's continued growth journey and reaffirms its commitment to delivering high-quality interior systems to leading automotive OEMs across India. With this expansion, having an approx. investment of Rs. 640 million, IAC India is poised to increase its production capacity by approximately 50%, further strengthening its ability to meet rising customer demand with agility and precision.

The first facility, an extension of IAC's existing site within the Mahindra Supplier Park, spans 94,000 sq.ft. will primarily support Mahindra Vehicle Manufacturers Ltd. (MVML). The second facility, adjacent to the Park, covering 70,000 sq. ft., has been developed to cater MVML and other major four-wheeler OEMs. Both sites are equipped with next-generation technologies including laser scoring, robotic ultrasonic welding, rotary conveyor systems, advanced cockpit production lines for Just-In-Sequence (JIS) delivery, Cut & Sew operations, and pressure lamination units. Designed with a sustainability-first approach, the facilities feature a roof-mounted solar power installation with a capacity of 750 KVA, ensuring up to 30% of their energy needs are met through renewable sources, as well as water harvesting and recycling systems.

This latest expansion signals the company's readiness to align with the evolving needs of the automotive ecosystem while reinforcing the Lumax Group's broader vision of driving growth through technology, quality, and sustainable practices.
