In Sr. No. B, TABLE III - Statement showing Shareholding pattern of the Public Shareholder: Non Institutions, Tab 4 (b), Directors and their relatives (excluding independent directors and nominee directors): There are 3 Directors who hold shares in the Company out of which 2 Directors i.e. Mr. Deepak Jain and Mr. Anmol Jain falls under the category of Promoter, therefore, here in this TAB we have only considered the shareholding of One Director who falls under the category of Public. Accordingly the details of One Director falling under public category has been mentioned here in this TAB. Clarification in respect of Annexure B: Stanley Electric Co. Ltd and Thai Stanley Electric Public Company Limited (belonging to Foreign Promoter Group Companies) jointly hold 37.50% of the Total Equity Capital of the Company. However, out of this only 26.74% is held through FDI route. Therefore, for the purposes of Annexure B, we have considered their holding as 26.74%, being shareholding through FDI route.
